The undersigned officers of Ironwood Villas Condominium Association Inc , a Florida not-for-profit corporation organized and existing to operate and maintain Ironwood Villas, Condominium, according to the Declaration of Condominium thereof, as recorded in O R Book 2010, Page 1912, et seq., Public Records of Sarasota County, Florida, was approved by majority vote of the voting rights at a special meeting of the membership held on the 17th day of January, 2001 The undersigned further certify that the amendment was proposed and adopted in accordance with requirements of the Condominium Documents and Florida law

Paragraph 11 11, PARKING No vehicle may be parked on the lawns of the units Parking of a recreational vehicle by a unit owner or a guest of a unit owner is permitted in the unit owner's driveway for a period not to exceed 72 consecutive hours ~~All other vehicles may be temporarily parked on the streets subject to the following provisions. No vehicle shall be parked on the street overnight. No vehicle shall be parked on the street so as to interfere with the delivery of mail. No vehicle shall be parked on the street so as to interfere with the access to a driveway, except, an invitee of a unit owner may park on the street at the unit owner's driveway if that driveway is full of vehicles. In no event shall a vehicle be parked on the street so as to interfere with the free flow of traffic~~

Only one trailer may be parked at a time. All other trailers pulled by another motor vehicle may park in their driveway for 72 consecutive hours in a seven day period

Recreational Vehicles that cannot fit on your driveway may park for 24 hours on a street for loading and unloading purposes , but must not interfere with mail delivery, free flow of traffic, or neighbors driveways

Boat or motorcycle trailers are not permitted to park on the street overnight

No commercial trailers or Recreational Vehicles used for commercial purposes are permitted to park overnight.
