Coverage Section

This Service Contract provides coverage for the equipment or assembly recorded above.

The service labor required shall be supplied in the event of a mechanical breakdown of a covered piece of equipment. This contract covers service labor only. Parts requiring replacement will be supplied per the Original Equipment Manufacturers parts Warranty terms or be repaired or replaced for a reasonable parts cost. Mechanical breakdown is defined as the sudden failure of a defective part or faulty workmanship as supplied by the manufacturer. This contract does not provide for acts of God, cleanings, flushing of system, seasonal check-ups, tune-ups, adjustments, normal maintenance, noise, sound blanket, and gradual reduction in operating performance due to normal wear and tear. This contract is inclusive of the manufacturer warranty and begins at the end of the manufacturer full labor warranty period and prior to the expiration date, as stated in the Registration section above. A full warranty is defined, as coverage including part and labor, and not a prorated status.

Warranty Costs:

One-year: \$139.00 plus tax, 2-year: \$239.00 plus tax, and 3-year: \$339.00 plus tax.

Coverage: This warranty removes any prorated status for the duration of this contract on all Original Equipment Manufacturers warranty labor coverage. Refrigerant Leaks: This warranty covers labor to repair the leak only. Refrigerant and related component parts are excluded.

Maintenance Requirement: Purchaser must maintain the equipment in accordance with the service requirements set forth by the manufacturer to keep this Service Contract in force. Evidence of proper service, when required by Administrator must be submitted in the event of a claim.

Hours of Service: Repair service and service calls will be made during normal working hours.

Labor coverage exclusions:

- Appearance features, esthetics, paint and cabinet parts, knobs and buttons
- Piping, high or low voltage lines external of the equipment
- Consequential damage caused by rust, oxidation corrosion, water, freezing, fire, lightning, general environmental conditions, insect or rodent infestation, or other natural acts of God
- Rigging and/or crane service, special tooling, blocks and tackle, dollies, scaffolds
- Improper installation, misuse, abuse, negligence, miswiring or non-connected wires
- Filters, duct work, vents, external fuses, belts, connectors, routine maintenance, periodic cleaning
- Premium service cost over normal service charges
- Accessories or non-standard additions
- "No problem found" calls are not covered under this contract
- Repairs that would not be covered under the manufacturer's original warranty for reasons other than the expiration of the manufacturer's warranty
- Services made mandatory by changes in Federal, State or Local regulations
- Damage due to insufficient electrical voltage, power surges, electrical circuit overloads, electrical spikes
- Accident, misuse, or abuse, whether willful or accidental
- Clogged drain line or gaskets which are considered maintenance
- Exterior disconnect box

Transfer: In the event this Contract is not cancelled, it may be assigned, or transferred, to subsequent owners if the maintenance required has been performed. This can be done only if Purchaser sends to Aquacal Autopilot Inc within fifteen (15) days of a change in ownership, the name and address of the new purchaser along with a copy of the original Service Contract. In the event of a transfer of registered equipment, due to manufacturer replacement, the original installation date will remain in effect for the duration of the contract

Cancellation: In the event the contract is cancelled by the warranty holder, return of premium shall be based upon 90 percent of unearned pro rata premium less any claims that have been paid or less the cost of repairs made on behalf of the warranty holder. In the event the contract is cancelled by the association, return of premium shall be based upon 100 percent of unearned pro rata premium.
